Sentencing Statement

~~It is, therefore, on 04/22/2016~~ **ORDERED and ADJUDGED** that the defendant is sentenced as follows:

Count 1
Four (4) years probation, subject to standard conditions.
364 days CCCF No programs for alternate service shall be permitted.

Defendant shall undergo a psychological evaluation and treatment if necessary.

Defendant shall abide by all of the terms of the Permanent Restraining Order entered separately this date.

Defendant shall provide a DNA sample.

The Court separately shall enter a permanent stalking restraining order pursuant to N.J.S.A. 2C:12-10.01.

The States request for forfeiture of Defendants Mac Pro Laptop Computer, and Apple Desktop Computer is denied. The State shall return to the Defendant any property seized from him immediately upon his release from incarceration, unless the State otherwise has initiated an appropriate civil action pursuant to N.J.S.A. 2C 64-3.

It is further ORDERED that the sheriff deliver the defendant to the appropriate correctional authority.
